

# Civil Rights Data Collection (CRDC) 2015-2016

## Part 2. Section X11: School Expenditures Line #30 and 43 Non-Personnel Expenditures

The general process we are recommending for this is to start from the 2016H\_EXPND\_AMT\_BY\_CAT csv file the district receives from ODE as part of the EMIS web reports for the period H EMIS reporting period. You will then sort and filter this file in Excel and add subtotals by IRN to come up with the school level totals needed for the Civil Rights reporting. The expenditure categories used by ODE already break out most of what is needed for the Civil Rights reporting, and the amounts have also already been allocated out to the school by IRN when necessary.

We recommend using the following procedure as a starting point. If necessary due to coding differences you can adjust your specific filters appropriately to include/exclude accounts to meet the criteria defined for these lines. Be sure to first review the Civil Rights reporting instructions at the beginning of Section X11 in addition to the specific instructions for lines 39 and 43 before beginning this procedure. ### 39. Amount of Non-Personnel Expenditures Associated with Activities Funded with State and Local Funds – All schools, grade K-12

- Start by opening the 2016H\_EXPND\_AMT\_BY\_CAT.CSV file in Excel
- Sort by the RPT-ALLOC-IRN (Column S). It's important to do this first as Excel doesn't seem to want to subtotal right if you wait to do this after you enter the filters. You may apply other sorts within IRN as well if you would like. An example of this might be to sort by the category code or by fund/scc within the IRN to make it easier to check.
- Use the "filter" option to filter on the following:
  - Include only Category Code (Column L) II.1, II.2, II.3, and II.5
  - Exclude all objects 1xx and 2xx (personnel related)
  - Exclude all 5xx funds except 512 and 532 (federal funds other than Impact Aid and State Fiscal Stabilization Fund)
  - Exclude fund 439 and function 1280 (preschool)
  - Exclude function 123x, 124x, 133x, 1350, 218x (special education)
- Use filters to exclude any other district-specific exclusion necessary not already excluded above. This would include, but not necessarily be limited to, the following items listed in the instructions:
  - Exclude programs that serve students from more than one school at a single school site
  - Exclude expenditures made by regional education agencies on behalf of schools.
- Finally, use the subtotal option to get the total per building
  - Select the entire spreadsheet
  - Select "subtotal" option and enter the following:
    - subtotal at each change in: RPT-ALLOC-IRN
    - Use function: sum
    - Add subtotal to: RPT-ALLOC-AMOUNT

**43: Amount of Non-Personnel Expenditures Associated with Activities Funded with Federal, State, and Local Funds – All schools, preschool-grade 12**

- Start by opening the 2016H\_EXPND\_AMT\_BY\_CAT.CSV file in Excel
- Sort by the RPT-ALLOC-IRN (Column S)
- Filter on the following:
  - Include only Category Code (Column L) II.1, II.2, II.3, and II.5
  - Exclude all objects 1xx and 2xx (personnel)
- Subtotal the amount by IRN in the same manner as for line 39
