FY 2011: Form 486

- After you receive your FCDL, submit Form 486
- Due 120 days after FCDL date or service start date (7/1/11) whichever is later
- If you received your FCDL before the service start date, the latest you can submit your 486 is **October 29th**

FY 2012: New Filing Cycle

- All ESC's, Defiance, Hicksville, Liberty Center, North Central Local & Oregon will need to include Internet Access Services on a **Form 470**
- Other Public Schools that wish to continue with their multi-year contract, do not need to file a new Form 470 for services being provided by NBEC

Children's Internet Protection Act Requirements – effective for FY 2012

1. Technology Protection Measure
 - Marshall 86 Internet Content Filter
2. Internet Safety Policy must address
 - Access by minors to inappropriate matter on Internet
 - Safety & security of minors when using email, chat rooms & other forms of direct electronic communications
 - Unauthorized access including “hacking” & other unlawful activities by minors online

Children's Internet Protection Act Requirements ~ Continued

- Unauthorized disclosure, use & dissemination of personal info regarding minors
- Measures designed to restrict minors' access to materials harmful to minors

3. Public Notice & Hearing or Meeting

- The authority w/ responsibility for administration of the school must provide reasonable public notice & hold at least one public meeting to address a proposed tech protection measure & internet safety policy

Examples of Documentation

- Published or circulated School Board agenda w/ CIPA cited as a topic
- A circulated staff meeting agenda w/ CIPA compliance cited as a topic
- An agenda or minutes from a meeting open to the public at which an Internet safety policy was discussed
